- A PROMISE ALWAYS INFERS THAT THE ACTUAL ARTICLE IN NOT PRESENT [OR NOT TO BE HANDED OVER OR CANNOT BE DELIVERED] AT THAT MOMENT OTHERWISE THE PROMISE WOULD BE IRRELEVANT WOULD IT NOT?
